
- to know the professional qualifications of his/her child's teacher(s), including the degrees and certifications held, and whether the teacher is certified in their respective area of instruction.

Odessa Upper Elementary is a Title I School. Title I is a federally funded program under the ESEA (Elementary and Seconday Education Act.)



What is the Title 1 Program?

Title 1 is the largest federal aid program for elementary, middle, and high schools. Through Title I, money is given to school districts around the country based on the number of low-income families in each district. Each district uses its Title I money for extra educational services for children most in need of education help. The focus of the Title I program is on helping all students meet the same high standards expected of all children.



Working Together

Parent Involvement is an important aspect of Title I. As a parent, you can influence your child's success in school. We encourage you to be actively involved in your child's education. You can become more involved with your child's education by:

- Joining your child's PTO.
- Supporting your school's extracurricular activities.
- Volunteering at your child's school.
- Keeping your child's teacher informed about events in your child's life that may affect his/her performance at school.
- Attending parent/teacher conferences and Title I Evaluation and Planning meetings.
- Communicating with your child's teacher regularly by phone, email, or notes.

What is the format and curriculum?



Students participate in their regular classroom reading and writing instruction.

Identified students are given ADDITIONAL small group reading and writing instruction from a Title 1 teacher.

The Title 1 curriculum is guided by the Missouri Learning Standards:

- Phonological Awareness and Phonics
- Vocabulary
- Comprehension
- Fluencu

After students are assessed, their individual data is used to choose lessons that best fit their needs. They are instructed using strategies guided by the science of reading, this includes direct instruction in the areas of phonemic awareness, and phonics.

- Read to your child, especially books that may be a bit challenging.
